## From the Board... Do You Have a Homestead Exemption on File?

We were recently contacted by a representative of the Tulsa County Assessor's Office regarding Homestead Exemptions. Recently a retired couple went to the Assessor's office to file a homestead after paying their final mortgage payment. The couple didn't realize that they could have saved thousands of dollars over the years if they only had the facts.

The Assessor's Office wants to ensure that everyone who is entitled to the Homestead Exemption has a current exemption on file.

In order to help our members, Mr. Ken Yazel, the Tulsa County Assessor, has generously offered to speak to a group of LLA homeowners about the Homestead Exemption. He could also bring a team to assure that all our members have registered home-

# No More Pool Passes



steads, including registering for the exemption at the meeting.

We have reproduced some of the information from the Assessor's Office web site regarding these exemptions:

#### About the Homestead Exemption

The Homestead Exemption is an exemption of \$1,000 of the assessed valuation of a primary residence you own. In tax year 2006, this would have been a savings of \$84 to \$132, depending on which area of the county you are located. In addition, there are <u>additional</u> exemptions for those who meet certain age and income requirements.

If you have been granted a Homestead Exemption and continue to occupy the homestead property, you are not required to re-apply for homestead exemption. However, if you change your deed, or move, you will need to re-file.

#### <u>To Qualify</u>

- You must be the homeowner of record who resides on the property by January 1.
- The property deed must be notarized on or before January 1 and filed with the County Clerk's Office on or before February 1.
- You must be a resident of Oklahoma.

#### <u>To Apply</u>

Homestead Exemption applications are accepted at any time throughout the year. However, the application must be filed by March 15 to be approved for the current year. <u>Any application filed after March 15</u> <u>can not be approved until the following year</u>.

- In Person: You may apply for Homestead Exemption at the Tulsa County Assessor's Office between 8:30 a.m. and 5:00 p.m. M-F. The office is located at the address shown at the end of this article.
- By Mail: You may use the enclosed form and return it by mail to the address below.
