From the Board...

By far, most of the residents in Longview Lakes abide by the covenants and restrictions concerning the use of a lot in our subdivision, which is that "None of the lots shall be used for anything other than single family residential purposes."

In addition to our covenants and restrictions, city codes restrict the number of residents per household.

Unfortunately, there are those residents who have two or more unrelated families living in the same home. Often this causes problems with inadequate parking, excessive trash, and (most seriously) potential health and fire safety issues.

Signs, Signs, Everywhere a Sign...

The City of Tulsa has begun to crack down on signs illegally placed in the city's right-of-way.



What may surprise some of you is that the right-of-way is at least 12 feet wide (even for residential streets) and may extend up to 20 feet wide for major roads. This measurement begins from the curb.

And yes, there is a fine for illegally placed signs: \$500—and maybe more in the future!

Mingo Mowing & Trash Problems

Some of you may not know that the city of Tulsa is responsible for the mowing and trash pickup along the right-of-ways of Mingo.

However, the city typically mows and collects trash only twice a year for most right-of-ways and medians. To help improve the look of our neighborhood, the association handles the mowing and pickup of trash along Mingo.

Lately, though, due to the heavy and persistent rains, and the careless litterers, the grass and trash situation became unacceptable. We have done, and will continue to do, our best to keep the right-of-ways maintained, but we could use some help from you:

- First, please don't litter;
- Second, if you walk around the neighborhood, please carry a plastic grocery bag or the like and help pick up trash; and
- Finally, the city will mow and pickup trash more frequently if we all complain. The number to call is the Mayor's Action Center at 596-2100.


