We continue to have issues with skunks, raccoons, possums, and other nuisance animals. Please make sure that they are not nesting in your yard (including under sheds or decks) and be sure to keep pet food so that pests can't get to it.

Unfortunately, due to cutbacks, our city's animal control department cannot always respond to a call about a wild animal. There are private companies that will trap and remove pests. We realize that this can be expensive, but bites (especially if rabies shots are required) are no fun for anyone.

The association receives many complaints about parked vehicles. Please remember that you should not park in a way that blocks sidewalks, driveways, or emergency access. Vehicles must not be parked on the grass. This includes boats and trailers.

Also, any vehicles parked in the street or in your driveway must be drivable.

Effective January 1, 2016 there is a \$1.00 per month service charge for delinquent accounts.

Our dues have not increased in years, leaving us (in effect) with less and less to work with each year. Every dollar collected is used to maintain and improve our neighborhood.

Quiet, Please!

Several residents have come to us with complaints about loud music and vehicles. Those of us that work at night need to be able to sleep during the day, and many residents are home even if there are no cars parked outside. Please be considerate and keep the volume down!

If necessary, you can file a nuisance claim with the police. Although they can't respond to every non-emergency call, multiple nuisance reports for a residence will help them prioritize their calls.

No Fireworks!

Fireworks are <u>illegal</u> in the City of Tulsa. If you want to enjoy fireworks...and save money... take in one of the many free area fireworks displays. They're far better than what you can do at home!
