Restrictions

Please help us keep our neighborhood looking like a respectable place to live. We have by-laws for the neighborhood that everyone must follow. If you don't, the City of Tulsa can potentially fine you if you do not comply with the request. There are some restrictions that you may receive a letter from the Homeowners Association asking you to take care of a violation.

If you see something that needs to be reported, please email us at <u>longviewlake@gmail.com</u> and attach a picture of the violation (if possible take a picture that includes the tag number). We will be happy to report it for you. Keep in mind, when we report any violation to the City of Tulsa, the violations are added to the inspector's schedule and due date is set. That due date could be up to 45 days later.

Some of the restrictions are as follows:

- Many complaints about parked vehicles.
 - You should not park in a way that blocks sidewalks, driveways, or emergency access.
 - Vehicles must not be parked on the grass. This includes boats and trailers.
 - Any vehicles parked in the street or in your driveway must be drivable.
 - You should not park vehicles such as semicabs and trailers, dump trucks, delivery vans and catering/food trucks in our neighborhood. These oversized vehicles block the sidewalks or make it difficult for other vehicles to pass on the street.

This is especially dangerous for fire trucks and ambulances that may need to get through in a hurry. The Longview Lake Association, Inc. is composed of all homeowners in the Longview Lake Estates. The Association is governed by a volunteer Board of Directors which are elected at large by all members on the second Thursday of November each year. The Covenants, Bylaws, Articles of Incorporation, Minutes of all meetings and Financial Statements are available to all members upon request. All Board meetings are open to members of the Association.

- Plan costumes that are bright and reflective. Make sure that shoes fit well and that costumes are short enough to prevent tripping or entanglement.
- Because a mask can limit or block eyesight, consider non-toxic and hypoallergenic makeup or a decorative hat as a safe alternative.
- A parent or responsible adult should always accompany young children on their rounds.
- By using a flashlight, children can see and be seen by others.
- Only trick-or-treat at homes that have a porch light on.
- Never enter a stranger's home or car for a treat.
- No treats are to be eaten until they are thoroughly checked by an adult at home.

Please Pay Your Dues on Time!

Homeowners that fail to pay their dues will be taken to small claims court.

As of January 1, 2016 we now charge a \$1.00 per month service fee for delinquent accounts.

Our dues have not increased in years, leaving us (in effect) with less and less to work with each year. Every dollar collected is used to maintain and improve our neighborhood.

LLA Dues and Pool Memberships can be paid with PayPal or one of these credit cards:



There are two ways to pay:

If you have a PayPal account, you can send payment of at least <u>3 months</u> (one quarter) of dues per payment to <u>mbrooks16@att.net</u>. Use "Send Money" and select "I'm paying for goods or services".

For proper credit, please be sure to specify your name and address in the message box. If you are paying for a Pool membership, you must still send us a completed pool application form.

Or

If you don't have a PayPal account, and wish to use a credit card, you must pay for an <u>entire year's dues</u> (or <u>the full pool membership fee</u>) at one time.

The following payment information is required:

Credit card number, Expiration Date, and CVV or CV2 (3 or 4 digit number on back of card)

Please send payment information and a copy of your statement to the address on your statement.
